HEY SENIOR!

i find love in the simple things.

I am so excited that you have booked with me for your senior portraits!

This is my TENTH year taking senior photos. yay yay! So I have compiled a few tips + tricks prior to your session to make things feel smooth. BUT if you have any other questions- shoot me a text :)





let's talk clothes.

depending on what package you get is how many outfits that are allowed. grab something that speaks to you, but will remain classic twenty years down the road.

something flowy is always a must. it gives you opportunity for playful photos! (peep the top left).

neutrals are always great, but im also a huge sucker for floral patterns

I tend to shoot in the editorial/ documentary style. the typical "senior portraits" are not quite my thing. getting you in your most comfortable state laughing at the camera is always a goal of mine.

payment.

payment is due the day of your photo session. **cash is highly preferred**, but I also accept checks made out to KORYN BENNETT.

photos are typically delivered around 6 weeks **+ please don't forget to tag me!** I love seeing the photos that are your favorites

location.

north point light house will always be my recommendaiton. it is the perfect spot. BUT if you're thinking you might want. another location, shoot me a text.

rescheduling.

it happens. and i'm very open to it. i would rather have you tell me that you're not liking how it looks outside than have me take photos that you're not going to love. i do not schedule rain dates, however i keep my week days open so that i can reschedule there.

delivery.

I deliver all my photos through pixieset. after delivery, please make a copy of the folder to your own desktop or a safe space asap- as mine copy may not always be around.

once your gallery is delivered, I am not longer responsible for it's safe keeping.

depending on the time of year, it may take longer to get galleries delivered. I appreciate your patience in advance



"candid."

candid photos are created through poses. I always say, "pretend im taking a video and keep moving once I pose you." whether that is shuffling your feet, twisting your body or having you giggle towards me.

the first five minutes of the shoot are always the most awkward. I'm a stranger with a camera - which I completely get. BUT after those first five minutes or running you through poses and sporting a few dad jokes, you'll get the hang of it!

contract

Ivylane Photo Company has the rights to any and all of the images taken, which may be used as advertisements unless specified by the client before hand. Ivylane Photo Company has creative rights to the photos and will not, under any circumstance, share the RAW or unedited photos taken. Photos are not allowed for commercial use, unless previously discussed with Ivylane Photo Company.

Ivylane Photo Company is not responsible for images after the initial delivery. Client must not alter or change appearance of photos. Photos may not be altered or edited in any way or fashion after they have been sent to you. This is vital to maintaining the integrity and artistic expression of the photographer's work. This includes the use of filters, coloration change or applying a border. If this is done, I may ask you to remove the photo. Ivylane photo company has sole creative rights to all photos.

Ivylane Photo Company does not watermark photos. When posting or sharing photos, please tag Ivylane Photo co. to give credit to where credit is due.

The fee of the Ivylane Photo Company is a set price in which the cost of the packages are selected by the client to fit their needs. I do not provide printed photos, only digital.

Photos generally take three weeks to five weeks to receive your photos. Please be respectful of this timing. Ivylane Photo Company takes extensive care of all equipment, however technical issues may arrive. A refund will not be available, however, a reshoot will be offered.

Ivylane Photo Company has sole rights to solely make creative choices as to cropping, lighting, coloring and which images become black and white/ color. If the photos are edited by the client there will be a breach in contract. Refunds are not available. If photographer agrees under the conditions, a re-shoot may be issued to the client.

In any case that one may be disappointed with their photos, I will offer a guaranteed reshoot at the same location as the previous at the soonest that I am available to. However, I will not issue a refund. Please contact me within 30 days of your receiving the photos if you are not in love with them. If one is does not contact me within the 30 days, a free reshoot may not be given. However, one may be quoted an hourly rate for reedits.

If one misses or cancels within 24 hours of their photo session, a 50% down payment will be issued if they schedule a new photo session.

All persons who book a session with Ivylane Photo Company are entitled and subject to contract.
